We use cookies and similar technologies (collectively referred to in this Cookie Notice as "cookies") to collect and use data as part of our services, as defined in our Privacy Notice ("Services"). By continuing to visit or use our Services, you are agreeing to the use of cookies for the purposes described in this Cookie Notice.

### 1. Cookies and similar technologies

Cookies are small data files stored in your browser or on your device. Cookies help us improve our Website and to deliver a better and more personalized service, for instance by storing information about your preferences and allowing us to recognise you when you return to our Website.

### 2. Cookie Types

The types of cookies can generally be classified into the following categories: (i) strictly necessary cookies, (ii) functionality cookies, (iii) analytics cookies, and (iv) advertising cookies. However, we only use analytics cookies on our Website.

We use both first-party and third-party cookies. First-party cookies are set by the Website you are visiting, while third-party cookies are set by a domain different from the Website you are visiting.

Cookies can be either session cookies or persistent cookies. Session cookies are deleted when you close your internet browser. Persistent cookies remain on your browser after you have closed it; for example, a cookie that tracks whether you are a new or returning visitor to the Website.

**Analytics Cookies**These cookies analyse how our services are accessed, used, or performing to provide you with a better user experience and to maintain, operate, and continually improve our services. They allow us to gather information about how visitors use our services.

The information collected from these cookies is used to generate site statistics, giving us insights into how often our services are visited, which parts or features are most viewed, and how frequently users interact with our services. We continuously strive to measure the popularity of our services and attract the maximum number of visitors and users. This enables us to make the structure, navigation, and content as user-friendly as possible.
